- Rare coins are graded on a scale of 1 to 70. Higher-graded coins are worth more than lower-graded coins. A coin graded MS66 (Uncirculated Mint State 66) will be worth many times more than the same coin graded MS62.
- The market strongly favors coins that are CAC-approved, which ensures their
  eye appeal and quality within their grade. Typically, they command premium
  prices and tend to appreciate in value more quickly over time than the same
  coin in the same grade without CAC approval.

#### **Demand:**

Popular series like Carson City Morgan Silver dollars and \$20 Liberty Gold
Double Eagles are consistently in high demand, especially in higher Mint State
grades. The high demand for these coins ensures liquidity and consistent
growth in value over time.

#### **Eye-Appeal:**

Rare coins are like snowflakes; no two are alike. You have to ask yourself, how
visually appealing is this coin? Collectors and investors pay premiums for coins
with exceptional eye appeal. Even if two coins have the same grade, a wellstruck coin with vibrant color, full details, and natural toning will sell for far
more than a dull or blotchy counterpart.

#### Key Types of Coins to Know for a Legacy Focused Collection:

#### Pre-1933 U.S. Gold Coins:

Removed from circulation during the Gold Recall of 1933, these coins were
melted down in large quantities, making those that remain in higher-graded
Uncirculated Mint State condition both rare and historically important.

#### Morgan Silver Dollars (1878-1921):

 Representing the Wild West and American expansion, especially those minted in Carson City, Nevada, these coins are highly sought after due to their limited mintages and fascinating history. A Legacy collection should aim to complete a high-grade Carson City subset, ideally with CAC approval and strong visual appeal.

#### **CAC-Graded or Approved Coins:**

- CAC (Certified Acceptance Corporation) graded coins command premium prices. Coins graded and encapsulated by other grading services with CAC green or gold stickers tend to outperform coins without one. CAC approval verifies that a coin is premium for its grade, adding an extra layer of confidence and trust.
- CAC-graded or approved coins are ideal for legacy-minded collectors and investors

#### **Understanding Rare Coin Grading and Key Terminology:**

#### CAC, PCGS, and NGC:

- These are independent third-party unbiased grading services that professionally authenticate, grade, and encapsulate coins to ensure buyers and sellers can trust what they're buying.
- They assign a coin a numeric grade on a 1 70 scale and seal it in a tamper-proof holder called a "slab." This protects the value, ensures authenticity, and makes it easier to sell and insure.
- Legacy Builders should focus on and prioritize CAC-graded and stickered coins.
   Coins that meet CAC's strict criteria add trust, prestige, and market value to a coin. A CAC-stickered coin already graded by PCGS or NGC verifies that a coin is "solid or high-end for the grade."

#### CAC coins tend to:

- Appreciate faster
- Sell for a premium
- Resell more easily
- Attract high-end legacy and generational wealth builders, collectors, and investors.

#### **Condition Rarity:**

These are coins with high mintages but have very low survival rates in higher
 Mint State grades, making them rare and valuable.

#### Mint State (MS) & Coin Grading Scale:

 Coins are graded on the Sheldon Rare Coin Grading Scale, which ranges from 1 (barely identifiable) to 70 (perfect coin with no flaws).

#### **Key Mint State Grades:**

- MS63- Clean but with noticeable marks
- MS65- Eye-catching luster, a few light marks
- MS67+- Premium coin; rare in many series

#### **Key Date and Low Mintage Coins:**

 Key dates (the hardest coins to find in a series) drive demand and subsequently increases their value over time. Low mintage coins are automatically rarer and command strong collector and investor demand.

#### **Mint Marks:**

Mint marks are small letters that indicate which U.S.
 Mint facility struck the coin. Mint marks are important as they affect rarity, desirability, and value. Carson City
 (CC) gold and silver coins are especially prized due to their frontier history and low mintages.


